I, _____, hereby certify that my dog(s):

is/are in good health, have not been ill with any communicable diseases or parasites in the last 30 days and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I also have read and understand and agree to the following:

1. _____I understand that All Dogs Club is an open-play environment and because of this there are inherent risks, which, even when monitored, may result in the following:

a. Transfer of a communicable illness' such as, but not limited to,
"kennel cough," also known as the Bordetella virus, "puppy warts" also known as the canine papilloma virus, or parasites.
b. Injuries, usually benign, such as broken nails, sore pads, bite and puncture wounds, abrasions and cuts, particularly in shorter coated breeds, torn collars, dirty and/or wet coats, etc.

2. _____Pet must be current on all vaccinations: Rabies (yearly), DHLPP (yearly), Bordetella (yearly) and must be on a scheduled prevention program during flea/tick season or when specifically requested by the Facility. Pets arriving with fleas and/or ticks may be bathed and treated at Facility's discretion, at Owner's expense. All dogs must be on heartworm preventative. The Facility reserves the right to refuse service to any dog.

3. _____If health problems develop with my dog(s), that these will be treated as deemed best by the staff of All Dogs Club within their sole discretion and that I assume full financial responsibility for any and all expenses involved.

4. _____All Dogs Club and their staff will not be liable for any health problems that develop in my dog(s), and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at All Dogs Club.

5. _____I am solely responsible for any harm, including to any other dog(s), to the employees or invitees of All Dogs Club, or to the equipment, physical plant, or other property of All Dogs Club, caused by my dog(s) while my dog(s) is/are attending All Dogs Club.

6. ______In case of an emergency, I authorize the All Dogs Club staff and/or their representatives to take my dog(s) to the nearest qualified veterinarian and authorize treatment. I understand that all costs in connection therewith, including transportation, veterinary, medical, and otherwise, shall be my responsibility and I am providing All Dogs Club with credit card information to be used for such purposes. I further understand that All Dogs Club will impose a twenty (\$20.00) dollar transportation fee and is not responsible for any injury, situation, or harm that should occur to my dog (s) during such transportation.

7. _____Photographs or other graphic, sound, or other image, likeness, recording, etc., may be made of my dog(s) by All Dogs Club and that such may be used for any purpose without compensation and I release to All Dogs Club all rights that I may possess or claim to such image, likeness, recording, etc.

8. _____I further agree that I, or a pre-approved agent, will pick up my dog by closing time on scheduled pick-up date. I fully understand that All Dogs Club closes and locks their doors promptly at 7:00pm and no dogs will be admitted or released after that time without exception. Any dog not picked up by 7:00pm

will be considered an overnight boarding guest and the credit card on file will be charged for said service. Any dog not picked up within 48 hours of scheduled pick up date will be considered abandoned. Any expenses incurred for the transport, overnight care, and/or placement or adoption of said pet shall be paid by the Owner in addition to other fees incurred for services provided by at or through the Facility. Owner hereby grants a lien on said pet for any and all unpaid charges resulting from services provided by at or through the Facility.

Hold Harmless Agreement

9. _____Although every possible precaution is taken when caring for your pet, we realize that animals can still be unpredictable, germs can survive even the best cleaning and human error can occur, despite training, supervision, and set policies. Therefore, All Dogs Club, its owner(s), employee(s), assignee(s), representative(s) or any other person affiliated with the company shall not be held liable for any health issues, illness, or injury (including death) that may result from ill health or actions of another dog, or action of All Dogs Club owner, employee, assignee, representative, or visitor.

Facility Booking and Cancellation Policies

10. _____Payment is required prior to services being rendered. If any charges are incurred during my dogs stay, I give All Dogs Club permission to charge my credit card on file for said charges.

11. _____All overnight boarding stays must be booked at least 24 hours in advance. All bookings and services must be paid IN FULL at the time of the booking. Cancellations made more than 48 hours in advance of scheduled arrival will be credited as a CLUB CREDIT to be used at ADC at any time for any services or retail. Cancellations made less than 48 hours of scheduled arrival will receive no credit.

12. _____ All Dogs Club DOES NOT perform refunds to original forms of payment, cash refunds or credit card refunds. All returns or 'refunds' will be issued as CLUB CREDIT. All 10 Day packages expire four (4) months after purchase. All 20 & 30 Day packages expire six (6) months after purchase and All VIP Packages Expire eight (8) months after purchase.

13. _____I have read and fully understand all terms of this agreement and the "Things to watch for in a new daycare dog" information sheet as well as the reservation, cancellation, and payment policies of ADC.

Refund and Cancellation Policy

- All boarding reservations must be booked at least 24 hours in advance to avoid a, \$8 'same day' reservation fee.
- All bookings and services (including packages) must be paid IN FULL at the time of the booking.
- Cancellations to boarding reservations made more than 48 hours in advance of scheduled arrival will be credited as a "CLUB CREDIT" to be used at ADC at any time for any services or retail.
- Cancellations made less than 48 hours before scheduled arrival will receive no credit.
- ADC does not perform cash refunds, credit card refunds or refunds to original payment methods of any kind.
- Club credit is not transferable.
- All 10 Day packages expire four (4) months after purchase. All 20 and 30 Day packages expire six (6) months after purchase and All VIP Packages Expire eight (8) months after purchase.
- One package per dog, packages are not transferable between dogs.

By bringing your pet to All Dogs Club and utilizing the services of All Dogs Club, you are aware of and consent to <u>all the above</u> conditions of All Dogs Club.
