Pets with fleas and/or ticks may be bathed and treated at Facility's discretion, at Owner's

expense. All dogs must be on heartworm preventative. The Facility reserves the right to refuse service to any dog.
3If health problems develop with my dog(s), that these will be treated as deemed best by the staff of All Dogs Club within their sole discretion and that I assume full financial responsibility for any and all expenses involved.
4All Dogs Club and their staff will not be liable for any health problems that develop in my dog(s), and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at All Dogs Club.
5I am solely responsible for any harm, including to any other dog(s), to the employees or invitees of All Dogs Club, or to the equipment, physical plant, or other property of All Dogs Club, caused by my dog(s) while my dog(s) is/are attending All Dogs Club.
6In case of an emergency, I authorize the All Dogs Club staff and/or their representatives to take my dog(s) to the nearest qualified veterinarian and authorize treatment. I understand that all costs in connection therewith, including transportation, veterinary, medical, and otherwise, shall be my responsibility and I am providing All Dogs Club with credit card information to be used for such purposes. I further understand that All Dogs Club will impose a twenty (\$20.00) dollar transportation fee and is not responsible for any injury, situation, or harm that should occur to my dog (s) during such transportation.
7Photographs or other graphic, sound, or other image, likeness, recording, etc., may be made of my dog(s) by All Dogs Club and that such may be used for any purpose without compensation and I release to All Dogs Club all rights that I may possess or claim to such image, likeness, recording, etc.
8I further agree that I, or a pre-approved agent, will pick up my dog by closing time on scheduled pick-up date. I fully understand that All Dogs Club closes and locks their doors promptly at 9:00pm and no dogs will be admitted or released after that time without exception. Any dog not picked up by 9:00pm

will be considered an overnight boarding guest and the credit card on file will be charged for said service. Any dog not picked up within 48 hours of scheduled pick up date will be considered abandoned. Any expenses incurred for the transport, overnight care, and/or placement or adoption of said pet shall be paid by the Owner in addition to other fees incurred for services provided by at or through the Facility. Owner hereby grants a lien on said pet for any and all unpaid charges resulting from services provided by at or through the Facility.
